

Main Changes :


- More andmore organized and dangerous groups,






Trade circuits from FRANCE

Powers of control:

Throughout the territory (article 60 CDN) and at sea (articles 62 and 63 of the CDN)


Investigative powers: In companies and at home Special investigative techniques

Judicial powers : National Judicial Customs Service (SNDJ)

Globlal customs seizures 2014-2019	5 000 kg
2018-2019	2 400 kg
2017-2016	1 500 kg
2015-2014	1 000 kg



Main problems in eel fishery control

- Eel care once the control has been carried out and the eel seized
- Difficulties in weighing seized eels
- Release in the naturel environmement whitout loss



Struggle of police and justice services against this traffic : a criminal response



. Specialized courts for organized traffic (prosecutors and judges).

This season , for the first time ; a criminal group was dismantled , from the fishermen to the exporter.

Samples of sentences :

- Fishmongers : up to 2 years of jail and fines from 30 000 à 50 000 eurosand seizure of luxury cars, lorries, cash, houses and fish. –
- Legal fishermen in offence : up to 6 months suspended prison sentence and fines up to 10 000 euros,
- Poachers: from 3 month suspended prison sentence to fines of 500 euros to 1500 euros
